It can read EPS and PSD files, supports PDF, CSV and TIFF formats, and can import most other file formats, which means you should have no problem sharing

your work with other people. You can use Adobe's online tools to convert between formats. Image formats You can download these files from Adobe or use another online converter. EPS Probably the most commonly used format, with a large number of applications. With one of these you should be able to export images in this format to almost every device that runs Windows (eg. the new iPad). PDF Images can be inserted into a PDF document and made interactive, in the form of a form that you can print and fill out. You can also insert hyperlinks within them. CSV Chunked text, similar to CSV (commaseparated value) files. TIFF A high-quality, lossless, raster format that stores each pixel separately. TIFF files are used by graphics programs such as Photoshop and GIMP. PNG This is the default format for vector graphics. PNG is a lossless format, which means that it won't lose quality when you compress or delete individual pixels. This means that it is always smaller than jpegs and gifs. JPEG A lossy format that is the most common kind of format for creating digital images. GIF An excellent format for text and graphs. It is commonly used to animate GIFs. However, GIFs are only a lossy format, which means that there will be some loss of quality as you compress the image. For this reason you should avoid using GIFs for high-resolution images. Video formats You can also create videos with Photoshop, which you can export in other formats. Petitioner Jerry Lee Thomas seeks a writ of habeas corpus to prevent the respondent in this action, Warden Donald E. Bailey of the Colorado Department of Corrections (Department), from evicting him from his cell in the Department's Maximum Security Building (Maximum Security) and temporarily placing him in

the adjacent Administrative Maximum Correctional Facility (Administrative Maximum) as a condition of release.
