Assistant Middlesex District Attorney Michael Field said his office intends to appeal that ruling. from the shooting scene on July 7, 2013. Keating ruled that Laranaga and Ramirez would be tried in Middlesex County Superior Court, with Essex Superior Court presiding over their arraignment. The ruling also means that Keating's decision, which was made after he heard five days of testimony in court last week and was based on an issue of venue, will have to be put on hold for at least 30 days. A new hearing will be held at Keating's discretion, based on what the defendants argue in their motion for change of venue.
